

**I. Swimming Pool**

A. Residents of/Property Owners within the Authority (“In-Authority”):

1. \$120.00/year family membership

B. Non-residents of/non-property owners within the Authority (“Non-Authority”):

1. \$300.00/year
2. Full payment due at time of membership.

**II. Pavilion at the Swimming Pool**

A. In-Authority:

1. \$25.00 non-refundable fee per event.
2. Full payment due in conjunction with reservation booking.

B. Non-Authority:

1. \$100.00 non-refundable fee per event.
2. Fully payment due in conjunction with reservation booking.

**III. Party at the Swimming Pool (Note: Pool membership required)**

A. In-Authority:

1. \$150.00 non-refundable fee per event, plus a \$25.00 refundable deposit.
2. Full payment (\$175.00) due in conjunction with reservation booking.

B. Non-Authority:

1. \$500.00 non-refundable fee per event, plus a \$250.00 refundable deposit.
2. Full Payment (\$750.00) due at execution of Swimming Pool Event Agreement.

**IV. Outlot A and Lake Christina**

A. In-Authority:

1. No additional fee\*\*

B. Non-Authority:

1. \$500.00 per vehicle per year\*\*
2. Full payment due at the execution of Park Use Permit and Agreement and/or Activity Participation, Assumption of risk, Release and Waiver of Liability.

\*\*Fishing at Lake Christina requires a fishing permit, see item V below.

**V. Fishing Permits**

A. In-Authority:

1. \$10.00 non-refundable fee per person (Children under the age of 16 do not need a permit when accompanied by a permitted individual).
2. Payment due at the time of receipt of fishing permit.

B. Non-Authority:

1. \$100.00 non-refundable fee per person.
2. Payment due at time of receipt of fishing permit.

**VI. Reservation of the Pavilion at Lake Christina**

A. In-Authority:

1. \$100.00 non-refundable payment and \$100.00 refundable deposit per event.
2. Full payment due at the execution of Park Use Permit and Agreement.

B. Non-Authority:

1. \$500.00 non-refundable payment and \$100.00 refundable deposit per event.
2. Full payment due at the execution of Park Use Permit and Agreement.

**VII. RV Storage**

A. In-Authority:

1. 490 sq. ft. space: \$300.00 per year
2. 675 sq. ft. space: \$420.00 per year
3. Payment due in accordance with the Vehicle Storage Agreement

B. Non-Authority:

1. 490 sq. ft. space: \$1020.00 per year
2. 675 sq. ft. space: \$1260.00 per year
3. Payment due in accordance with the Vehicle Storage Agreement

**VIII. Community Building Rental for Parties**

A. In-Authority:

1. \$150.00 non-refundable payment and \$150.00 refundable deposit per event

B. Non-Authority:

1. \$300.00 non-refundable payment and \$300.00 refundable deposit
2. Payment due at the execution of Community Center Use Permit and Agreement

**IX. Equestrian Facilities and Trail System\*\*\***

A. In-Authority:

1. No additional fee

B. Non-Authority

1. \$500.00 per person, per year
2. Payment due at execution of Park Use Permit and Agreement and/or Activity Participation, Assumption of Risk, Release and Waiver of Liability.
